Measure 2.2: Enabling Access to Quality Education for Ethnic Communities

4. Description of the Operation

4.1 Synthetic description

This operation will support the integration of ethnic communities in the educational system.

The objective of this operation is to ensure equal access to quality education for pupils of all ethnic communities in order to promote their better integration into the educational system and, consequently, higher educational results, higher educational level and professional qualification. Achievement of better integration and socialization of pupils belonging to various ethnic communities is extremely important for the Country and its multicultural society.

In order to ensure a balanced approach in enabling access to quality education, a preliminary assessment will be required to verify the current situation. A balanced approach will be primarily important given the different level of integration of various ethnic communities into the educational system.

The operation will be implemented through one twinning contract.

The twinning contract will have two components structured into the following eligible actions:

Component 1 " Including intercultural aspects in the educational system":

- Action 1: Updating the curricula with elements for intercultural education;
- Action 2: Introduction of innovative programmes for education and training.

Component 2 "Strengthening capacities to support integration of ethnic communities":

- Action 1: Training of the teaching staff and directors;
- Action 2: Training of the parents of Roma pupils.
